<b>Why or why not?</b>	We have abided by the SDOneCall Regulations and we don't ever have any issues with any other utility company, other than Midco. This is because Midco only installs the cables a few inches below ground. Even though we DO hand dig, these lines are so close to the surface, that they are being hit by the shovels....as they should be well below the dig area. Underground Solutions should not be able to install drops in Sioux Falls, due to installation method. We have found the drops from 2 to 6 inches for the majority of the time, and at this depth, they are easily damaged. All other providers install at 12 to 16 inches in depth. This is also a liability to the homeowners as well. They are the 1st ones to install, so this shouldn't be an issue.
