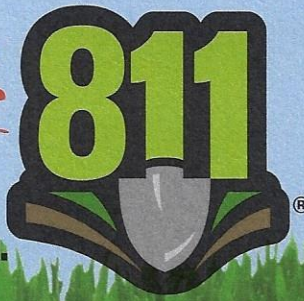

Under the authority granted by SDCL-49-7A-22, the Enforcement Panel of the South Dakota One Call Notification Board met on February 28, 2020 to determine whether there is probable cause to believe a One Call violation occurred in Complaint Docket OC20-012. The Enforcement Panel's findings are enclosed. You may request a hearing according to SDCL-49-7A-27, if you disagree with the Enforcement Panel findings. If you do request a hearing you must be represented by legal counsel at the time you present your case to the One Call Board.

**Failure to respond to this notice or request a hearing is considered acceptance of the Enforcement Panel Recommendation. In that case, the Recommendation will be Ordered by the South Dakota One Call Notification Board and your right to hearing is waived.**

**If you choose to request a hearing you must return the signed and dated form prior to the close of business on May 8, 2020.**

**ENFORCEMENT PANEL  
RECOMMENDATION TO THE SOUTH  
DAKOTA ONE CALL BOARD**

OC20-012

On January 24, 2020, the South Dakota One Call Board received a Complaint filed by Midcontinent Communications (herein “Midco”), against Sod Busters Inc. and B Green, (herein “Respondent”) for an incident occurring on June 5, 2019, at 4301 W. Kinsley Pl., Sioux Falls, SD. The Complaint alleges a violation of SDCL 49-7A-5 and 49-7A-12 when Respondent did not perform locates prior to doing underground sprinkler repair and cut the cable.

A copy of the Complaint was sent to Respondent on January 28, 2020. Respondent answered the Complaint on February 18, 2020 and denies a violation of South Dakota One Call law. Respondent alleges they do hand dig, but Midco’s lines are so close to the surface that they are being hit by the shovels. Respondent states they did not request a locate.

On February 28, 2020, the Enforcement Panel (herein “Panel”) convened pursuant the authority present in SDCL 49-7A. Pursuant to SDCL 49-7A-21, the Panel dismisses this action because the Complaint was not brought within ninety (90) days of damage or within one (1) year of discovery.

The Panel recommends the South Dakota One Call Board accept its findings and recommendations herein. If either party to this Complaint disagrees or objects to the recommendations or findings herein, a hearing may be requested. To request a hearing, a party must reply within twenty days from the date of service of this notice. Failure to request a hearing is considered acceptance of the recommendations and findings herein.

The South Dakota One Call Notification Board has jurisdiction in this matter pursuant to SDCL Chapters 1-26 and 49-7A and ARSD 20:25.
