






- 1) It is the law that 811 must be called prior to any excavation, grading, or movement of dirt.
- 2) Locates must be called in 48 hours prior to excavation.
- 3) No excavation, grading, or earthmoving work shall be performed prior to locates being called in.
- 4) Site managers and operators must verify that locates have been called in and that utility / underground lines have been marked. If you are working on a site and do not see locating flags or marks, please contact your site manager or the office immediately so that we can verify that locates have been called in.
- 5) Employees must hand dig within 2 ft of marked utilities.
- 6) If markings are destroyed due to work, call you project manager or the office so that we can call in a respot.
- 7) If a gas line is damage, call 911 IMMEDIATELY and clear the area.
- 8) If an underground facility is damaged, ensure that everyone is ok and make sure there are no immediate safety hazards to individuals on site. Contact the office IMMEDIATELY, as well as the project manager. Please take note of whether the line was marked, what type of line, if service to customers is out, the location on site, and other details so that we can provide as much information to the 811 center as possible when reporting the damage. Take photos if it is safe to do so.
