Describe your allegation:	On November 10, 2020, Magellan's Damage Prevention Operator (DPO) drove to the excavation site and observed the installation of fiber cable 15 feet away from the pipeline. Prior to this date, several attempts were made to request that a Magellan representative be on site during excavation. Donarski Lawncare and Landscaping did not respond to these communication attempts and is therefore in violation of Magellan's procedures by not having a representative on site during excavation.
